Able Limited Editions strongly advise any prospective buyer whatsoever of any product whatsoever offered for sale by Able Limited Editions on any Able Limited Editions site to read all the Terms & Conditions below; along with any other product specific Terms & Conditions, Shipping Policy and Privacy Policy posted on any product specific web site pages; before they purchase any. Able Limited Editions will assume purchasers so did and Able Limited Editions will thereby not be liable for any said damage whatsoever suffered by any person whatsoever outwith UK statutory rights of purchase.
2. © Copyright Able Limited Editions regarding any Able Limited Editions publication means production, publication, sales and distribution of such publications are the rights licensed or assigned to Able Limited Editions by their author/s under UK Copyright, Designs and Patents Act 1988 and all the related legislation. No part whatsoever of any such publication may be stored in any type of retrieval system whatsoever and or copied, reproduced, transmitted or broadcast by any means whatsoever by any person whomsoever without prior, unambiguous and endorsed permission in eligible English writing legally and lawfully obtained from Able Limited Editions.

4. Able Limited Editions will not be liable for any purchaser of any ebook offered not taking reasonable steps to apply parental/guardian guidance to any non-sui juris person or any person under sixteen years of age who reads their CD copy, copies, or download/s.
5. Except where imposed under UK statutes, Able Limited Editions will not be liable for any damage whatsoever caused howsoever to any purchaser of any product offered, any third party whatsoever or any other person whatsoever.
6. Invalidity of any part of any contractual term or condition hereof in itself will not invalidate any other part and or term and or condition hereof.

2. Unique CD Text Format :-

9. Legally and lawfully available copies of any Able Limited Editions UNIQUE EXE CD TEXT FORMAT publication are only available to buy in the UK from Able Limited Editions via land mail by cash, postal order, cheque or online via PayPal. And only the strictly limited total of twenty-five (25) produced Unique EXE CD Text Format copies of each title (publication) will be made publicly available to purchase exclusively via the Able Limited Editions Online pages of this www.ablelimitededitions.co.uk website on a first come first served basis. Any other said Unique CD copy will in fact and law be illegally obtained.
10. The purchase price per copy of any UNIQUE CD TEXT FORMAT publication includes free ordinary first class postal delivery to any UK postal address. It also includes free entry into a

competition and lifetime membership of the Able Limited Editions Arena (see below).

11. Each legal CD of any Able Limited Editions UNIQUE CD TEXT FORMAT publication will have a unique Identifier. Each Identifier entitles its legal purchaser to enter the competition outlined below once. But copies purchased directly from Able Limited Editions will only be available to UK buyers and thereby posted by Able Limited Editions to any valid UK land mail address.

19. 23. 24. But valid members may choose not to receive any such email any time after their initial registration.

30. Duration of membership will be :-

Able Limited Editions, through their Online Shops known as www.lionebooks.net and www.arenaebooks.com also offer a large selection of zipped pdf and exe ebooks and some software tools published/produced by other publishers/producers. The product/s will then be sent to the purchaser's UK land mail address within five (5) working days from the date Able Limited Editions receives payment.
